1. I am the attorney for defendant Shawn McKenzie in the above-entitled matter;
2. Shawn McKenzie voluntarily testified at the grand jury proceedings in this case;
3. Shawn McKenzie was asked to state information on where he grew up and resided;
4. Shawn McKenzie is concerned that persons reviewing the grand jury transcripts will be able to obtain his personal information, including his current and prior places of residence;
5. This case concerned a fatal shooting of an armed man during an incident on or near the Portland State University Campus and has received wide publicity;

5 residence is made to further insure his safety as well as the safety of his family members;

7 this request and he does not oppose the motion.
